

# **POOL SURFACING 2000, INC. FIBERGLASS MATERIAL WARRANTY**

For a period of 15 years from the date of installation, **POOL SURFACING 2000, INC.** (referred to as **PS 2000**) at no cost to the original Buyer for **materials**, will repair any completed fiberglass surface installed by **PS 2000**. The surface is warranted against rebar rust, leaks, bubbles, cracks, and delaminating. If such failure should occur within **five years** of the installation, **PS 2000** will provide **labor and materials** for repair at no cost to Buyer. **Commercial spas** carry only the **five year** warranty described above.

## **LIMITATIONS AND EXCLUSIONS**

**PS 2000** will not be responsible for any work performed on a warranted surface by any party other than **PS 2000** or their authorized agents. This warranty does not cover materials such as, but not limited to, tile, coping, plumbing, electrical and equipment replaced. This warranty does not cover damages caused or contributed to by accidents, abuse, misuse, or exposure to fire or hazards of nature, including floods, ground faults, and shifting, settling of soil or expansive soils. This exclusion also includes any other act of God or occurrence that **PS 2000** cannot control. This warranty does not cover fading or uniformity of color. This warranty does not cover discoloration due to, but not limited to, the improper use of chemicals, or improperly maintained water chemistry. This warranty is effective provided the surface remains structurally sound and filled with water at all times, except those days (not to exceed 5) needed for any surface, plumbing or equipment repair. This warranty is applicable only if the Buyer has complied in full with terms of payment and other conditions of the contract between **PS 2000** and the Buyer covering installation of the surface. This warranty does not cover damages caused by, but not limited to, water loss or excessive down time over the five day period. **PS 2000** is not responsible for providing pool chemicals or replacement water cost. **PS 2000** is not responsible for special incidentals, including but not limited to, electrical use, or any loss of revenue due to down time. Commercial spas carry only the five year warranty described above.

## **REPRESENTATIONS**

This warranty is in lieu of all other warranties expressed or implied, oral or otherwise. **PS 2000** makes no other representations, except in writing herewith.

## **NOTIFICATION**

Please notify **PS 2000** in writing before water is to be removed from the surface. In the event of a claimed defect, **PS 2000** shall be immediately notified in writing of such a defect. Notification shall be to:
